I. RATE OF SUCCESSFUL COMPLETION - POLY Languages Institute (POLY) offers English as a Second Language (ESL)/Test of English as a Foreign Language (TOEFL) program. POLY offers twelve (12) four (4)-week terms per year. The length of the program will vary depending on students' placement and educational goals. POLY does not offer degrees; do not be confused by the terms, Graduation and Graduates, below.

(1) "Number of Students Who Began Program" is the number of students who began the Program who are scheduled to complete the Program within the reporting calendar year.
(2) "Students Available for Graduation" is the number of students who began Program minus the number of "Students unavailable for Graduation," which means those students who have died, been incarcerated, or called to active military duty.
(3) "Graduates" is the number of students who completed the Program within $100 \%$ of the published Program length.
(4) "Completion Rate" is the number of Graduates divided by the Number of Students Available for Graduation.
II. EXAM PASS RATE - The ESL/TOEFL program does not prepare students to sit for any licensing exam. The TOEFL is a test to measure the English proficiency and academic skills of nonnative speakers of English.
III. RATE OF EMPLOYMENT - The program is not for employment.
IV. EMPLOYMENT DISCLAIMER - The program is not for employment. Furthermore, for non-immigrant students, please note that unauthorized employment in the US will terminate your status.
V. NOTICE CONCERNING TRANSFERABILITY OF UNITS EARNED - The courses taken at POLY are not transferable to any college or university. However, the colleges and universities that have articulation agreements with POLY will accept students who successfully complete (C or better) the most advance level reading/writing or listening/speaking courses to their program without the minimum TOEFL score requirement.
